

PRIVACY POLICY

Effective Date: January 27, 2015

Mokasoft.com (the “Website”) and its related services and products, including without limitation, Sentencing Guidelines Calculator for Michigan and Judgment Interest Calculator for Michigan (collectively, the “Application(s)”) is owned and operated by Mokasoft, LLC (“Mokasoft” or “We”), a Michigan limited liability company. By visiting the Website or using the Application(s), you understand and agree to accept and adhere to the following terms and conditions as stated in this Privacy Policy, along with the terms and conditions as stated in our Terms of Use Agreement. Mokasoft has adopted this Privacy Policy (“Privacy Policy”) to inform you that it collects personal information (“Personal Information”) when you use the Website or Application(s) and to explain how this Personal Information is used.

1. Mokasoft may collect the following Personal Information from you:

1) Any information that you submit to the Website, Application(s), Youtube, Social Media or similar third party sites or applications; 2) First and last name; 3) Email address; 4) Country; 5) Business name, business website, business email address; 6) Payment information; 7) Other required account or other information visible to the User as requested by the Website or Application(s); 8) Your IP address; 9) Phone number; 10) Address book and contacts; 11) Mobile device ID, device name, and OS name and version; 12) Your geolocation; 13) Your use of the Website and Application(s); 14) Information stored in cookies, pixel tags, or web beacons; 15) Analytic data from Google Analytics; 16) Account holder and payment information; and 17) Any other additional analytic data that you voluntarily submit to the Website or Application(s)

Mokasoft may collect this personal information from you through various channels, including, but not limited to, through your voluntary submission of information to the Website or Application(s), through requests initiated by you through the Website or Application(s), through communication with third parties such as banks, through the collection and analysis of information concerning your computer and browsing activities, through the use of cookies, web beacons, pixel tags, Google Analytics, and through other sources permitted by law.

2. Use of Cookies and Other Tracking Techniques

Mokasoft may collect Personal Information from you through its use of cookies or other tracking techniques. Cookies allow the Website and Application(s) to recognize your computer or mobile device and preferences when you revisit the Website or Application(s). Session cookies help to remember your preferences on a single visit to the Website or Application(s) and your browser will normally delete these session cookies upon closing. Web beacons and tracking pixels are objects embedded in a

web page that allow Mokasoftware to analyze whether a user has visited a specific page. Mokasoft may remove the cached content at any time, within its sole discretion, although Mokasoft cannot guarantee that the cached content will be permanently deleted. Accordingly, any User Generated Content that you send or receive is done so at your own risk. Mokasoft does not provide any means for you to delete the cached content.

Your Personal Information is stored and processed on computers in the United States and, through your use of the Website or Application(s), you unequivocally consent to the processing and storage of your Personal Information within the United States. Be advised that the laws of the United States may not be as protective of your privacy as those in your location. You understand and agree that Mokasoft may continue to store your information after you cease use of the service or disable your Account.
